It is that time of year for mare owners to start planning and dreaming about reaching the ultimate goal of that magical stallion cross in hopes of producing the next racing superstar!

As the song by Tracy Lawrence says "the only thing that stays the same is everything changes" QHRAI has also had to deal with changes and uncertainties because of COVID-19, given the changes that we are all being forced to adapt to we have decided to join the Online Auction communities. In Indiana 80% of the funds collected from the sale of Stallion Services are added to a Futurity and Derby that are restricted to offspring of the Stallion that sold in the appropriate year. If your stallion sells thru our auction **ALL** offspring are eligible for the **\$100,000+ ADDED FUTURITY** and the **\$75,000+ ADDED DERBY** in Indiana. In 2020 the purse money for the Futurity was \$178,828 and the Derby was \$107,332. We have seen growth in the last few years and are committed to continuing to grow the program and are asking for your help by donating your stallion service to the 2021 Stallion Service Auction.

Still not convinced? Would you wager on your stallion's progeny? Can he produce the best of the best?
